**MOTION FOR JUDICIAL DEFAULT AND MOTION IN OPPOSITION TO
SECOND MOTION FOR EXTENSION OF TIME**

Plaintiff, POMPANO SENIOR SQUADRON FLYING CLUB, INC. (Plaintiff "Flying Club"), by and through its undersigned counsel, files this Motion for Judicial Default and Opposition to Second Motion for Extension of Time against Defendant CARL KENNEDY (Defendant "Kennedy") and says:

1. Plaintiff Flying Club filed suit against Defendant Kennedy on or about April 7, 2020, almost three (3) months ago.
2. After being served, Defendant Kennedy entered into an Agreed Order with Plaintiff Flying Club, based upon Defendant Kennedy's request for an extension of time so that he could obtain counsel, granting that extension. The Agreed Order was entered by this Court on June 5, 2020, and gave Defendant Kennedy until July 1, 2020, to file responsive pleadings to Plaintiff Flying Club's Complaint. A copy of Order is attached hereto as Plaintiff Flying Club's Exhibit #1.
3. Now, on July 1, in defiance of that Agreed Order, Defendant Kennedy now files a Second Motion for Extension of Time and improperly cites to a Bar Complaint as a
