To mute your device:

- **Laptop** – Click the microphone icon toward the bottom center of the screen
- **Telephone** – Dial *6
- **Desktop** – Click the microphone icon toward the bottom center of the screen
- **Tablet** – Click the microphone icon toward the bottom center of the screen

- Join the audio via cell phone or speakerphone for a clear connection.

Do not join from both computer audio and telephone audio. It will create horrible feedback. We suggest always use the camera on your laptop or device and dial in on the telephone for audio.

Dial the telephone number in the invite and enter the zoom meeting ID when prompted. Then enter your personal zoom ID Given to you when you created your free account login and press # *(this will link your video and voice together in the zoom call)*

- All participants are asked to use their first and last name when signing in.

- If there are exhibits to be presented, there is a feature under the chat tab that allows files to be uploaded. A copy of the exhibits prior to the deposition is needed for the reporter.

- There is a feature in the chat to raise your hand if you have any questions or concerns.

- Please find a quiet place to conduct the deposition, hearing, etc. The reporter will need to be able to hear you clearly.

- The reporter will need only person at a time to speak. He/she cannot take down the information if more than one person is speaking.

- The Zoom rooms are opened 15 minutes prior to your deposition starting to allow all parties to connect and set up.
