- 3. List each and every action I took or any expense I paid using PBFC funds which you contend represent(ed) mismanagement of funds, describing specifically with respect to each action or expense why you contend the action or expense constituted mismanagement of Club funds.

4. List each and every personal credit card and debit card used by any Officer or member of the Board of Directors, since February 12, 2020, to pay or for which reimbursement has already been or is expected to be repaid, any expense using Club funds, stating in whose name the card is held, the

date and to whom the expense was paid, including any amounts.

5. List any and all credit cards and debit cards held specifically in the name of Pompano

Senior Squadron Flying Club and Pompano Beach Flying Club since February 12, 2020.

6. Identify and describe in detail the original source(s) of all funds, other than member dues [including credit cards, sale of assets, member initial deposits (\$1700 or other "buy-in funds") etc.], used for all payments for all expenses of PBFC (including but not limited to fuel, hangar costs, insurances, maintenance, professional fees and costs, etc.), and whether or not any Officer, member of the Board of Directors or regular member contributed to the payment of these expenses in any amount in excess of their monthly dues (regardless of whether reimbursement has been or is expected), and if so, the name of any Officer, member of the Board of Directors or regular member

making such contributions, and whether reimbursement has been or is expected to be paid to each.

7. Identify payments of any kind that have been made by PBFC to any member or former member of PBFC since February 12, 2020, including reimbursements, loan payments and return of funds, providing the name of the individual(s) to whom such payments have been made as well as the

date, amount and purpose for which each payment was made.

8. Identify by name, date, amount and purpose of all funds or any form of payment received by PBFC from any new member(s) of PBFC since February 12, 2020.
