

TO Each Sheriff of the State:

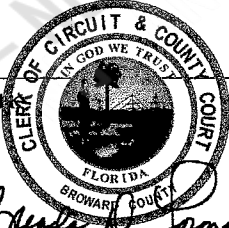
