**NOTICE TO CLERK OF THE COURT**

Plaintiffs LLOYD DAVID HILL and GRAHAM DAVID HILL, proceeding in Small Claims Court *pro se*, respectfully submit this NOTICE to the Clerk of the Court and say:

1. Plaintiffs have irreconcilable scheduling conflicts on August 17-19, 2020, the first date being the currently-scheduled date of the pretrial conference.
2. Plaintiff Lloyd Hill is obligated to help his college Freshman daughter move into her campus dormitory at the University of Central Florida in Orlando. Plaintiff's daughter has been given a narrow move-in window on the afternoon of August 16, 2020.
3. The COVID-19 pandemic has caused significant disruption and uncertainty with respect to academic schedules and operations, and Plaintiff Lloyd Hill therefore plans to stay in the Orlando area at least the following day to make sure his daughter is settled in without further need of immediate support.
4. Plaintiff Lloyd Hill also has a non-flexible job-related training obligation on August 19, 2020 that precludes moving the pretrial conference on August 19, 2020.

5. Plaintiff Lloyd Hill contacted counsel for Defendant in advance of submitting this NOTICE to the Clerk of the Court, and Defendant does not object to this brief delay.

6. Counsel for Defendant reported that they would be unavailable due to other conflicts on August 18-21, 2020.

7. Based on the aforementioned, both parties will be available for case-related events for the balance of August, commencing on August 24, 2020.

8. Plaintiffs also take this opportunity to report reasonable availability at any time for pretrial conference or other case-related events in September except for the period of September 19-25, 2020, when Plaintiff Lloyd Hill has another non-flexible job-related training obligation.

9. Plaintiffs will follow this notice up with a phone call to the Clerk of the Court.

10. Plaintiffs therefore respectfully request the Court to approve this brief delay for good cause and that the Parties be notified of the new pretrial conference date and time.
