**STIPULATION FOR ENTRY OF AN AGREED ORDER
REGARDING CLERK DISBURSEMENT OF SUPERCEDAS BOND**

COME NOW the Plaintiff, STEVEN J. BORER, and the Defendant, POMPANO SENIOR SQUADRON FLYING CLUB, INC., by and through their respective undersigned attorneys, and STIPULATE AND AGREE as follows:

1. A Final Judgment against Defendant in the sum of \$1,930.00 was entered April 7, 2021.
2. Defendant filed a Notice of Appeal with the Court on May 4, 2021.
3. Defendant posted a supersedeas bond with the Clerk of the Court on May 4, 2021. The bond complied with Rule 9.310(b)(1) Fla. R. App. P. by posting the amount of the judgment face, with interest.
4. The appellate court issued its PCA decision December 1, 2021.
5. Defendant has not sought a re-hearing of that decision.
6. Defendant agrees that Plaintiff is entitled to have the bond money posted by Defendant.
7. The total amount owed on the face of the judgment as of December 1, 2021

was \$1,984.24, which includes accrued post-judgment interest.

8. To avoid further litigation and judicial labor, Defendant agrees that the sum of \$1,984.24 shall be paid by the Clerk of the Court to "Jeffrey Lampert Trust" c/o Plaintiff's attorney, Jeffrey B. Lampert, 1615 Forum Place, Suite 4-B, West Palm Beach, FL 33401 and upon receipt of funds, Plaintiff shall file a Satisfaction of Judgment.

9. Plaintiff agrees that the remaining funds held by the Clerk shall be remitted to Defendant by payment to Edward F. Holodak, P.A., Trust Account and sent to Edward F. Holodak, Esq., 3326 NE 33rd Street, Fort Lauderdale, Florida 33308.
